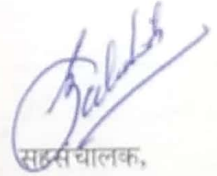

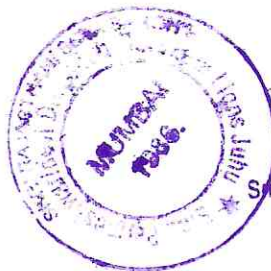

5. For lectures / demonstrations / tutorials, project work must be in accordance with the rules prescribed by the government.
6. It is necessary to certify the reservation point nomenclature through the prescribed authority as per the prevailing reservation policy of the government as per the posts sanctioned in the college.
7. If the number of students decreases in the next academic year or if the workload in the subsidized department is reduced due to other reasons, the permissible number will be reduced.
8. 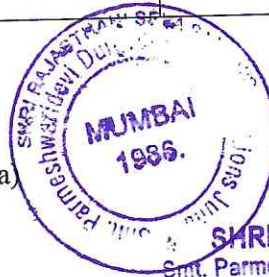

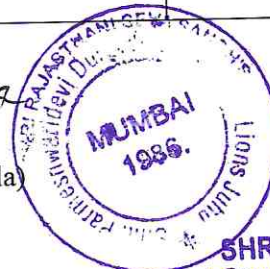
