Attention of the Principals of the Affiliated Colleges and Directors of the recognized Institutions is invited to University circular No. Spl. Cell/68/218/2005 dated 3rd June, 2005 in which distribution of seats in minority and non minority institutions (aided and unaided) has been mentioned. The clarification about 15% management quota was also given in the said circular.

Your attention is also invited to the Circular No. Aff./Recog./Admission/(2018-19)/9/ of 2018 dated 30/5/2018, No. Aff./Recog./Admission/(2018-19)/10/ of 2018 dated 30/5/2018, No. Aff./Recog./Admission/(2018-19)/11/ of 2018 dated 05/5/2018 and No. Aff./Recog./Admission/(2018-19)/12/ of 2018 dated 05/5/2018 regarding pre online registration and admission to various categories including minority.

As per the judgment dated 12th October, 2017 by the Hon'ble High Court, Bombay, in Writ Petition 1726 / 2001 in the matter of St. Xavier's College and Maharashtra Association of Minority Education Institutions v/s. Mumbai University and State of Maharashtra, in respect of reservation of seats to the backward class candidates shall not apply for Minority Educational Institutions affiliated to the University of Mumbai.
