The clarification about 15% management quota was also given in the said circular.

No. Circular invited also attention is: Your No. 30/5/2018, dated Aff./Recog.l/Admission/(2018-19)/9/ 2018 30/5/2018. Mo. dated Aff /Recog l/Admission/(2018-19)/10/ 2018 of Aff./Recog.l/Admission/(2018-19)/11/. of 2018 dated 05/5/2018 and No. Aff (Recog.)/Admission/(2016-19)/12/ of 2018 dated 05/5/2018 regarding pre online registration and admission to various categories including minority.

As per the judgment dated 12" October, 2017 by the Hon'ble High Court, Bombay, in Writ Petition 1726 / 2001 in the matter of St. Xevier's College and Maharashtra Association of Minority Education Institutions v/s. Mumbai University and State of Maharashtra, in respect of reservation of seats to the backward class candidates shall not apply for Minority Educational Institutions affiliated to the University of Mumbai
