Hence, metric Id 2.4.3 average teaching experience, metric Id 2.4.2 average percentage of full time teachers with Ph.D, metric id 2.3.3 ratio of mentor and metric id 2.4.1 average percentage of full time teachers were affected in Criterion II.

I appeal to consider the newly added documents for the same as well as for further proceedings.
